MITIGATION

Mitigation aims to eliminate or reduce the impact of a threat or challenge from creating long-term disruption to the advancement of racial equity. By anticipating resistance, government can prepare tools and communication plans to counter harmful narratives, build community support, and align partnerships around shared equity goals.

Risk Analysis

How can we evaluate the potential negative impacts of the situation/actions and advise leaders how to navigate the changing dynamics? **Conduct risk analysis** of racial equity plans and initiatives to determine the most effective aims of focus.

Assess the infrastructure and staffing required to drive forward ongoing plans and initiatives.

Identify probable disruptions to racial equity work and assess for preventative or abative measures.

Aligning Strategies

How could we update our racial equity plan to navigate the changing dynamics of this current political environment? **Ensure that any name or brand changes keeps valuesbased language** that serves racial equity.

Plan continued support while addressing inequities for vulnerable populations and targeted communities.

Back local businesses, organizations, and community efforts committed to equity mitigating federal disinvestment.

Early Warning Systems

How could we remain alert to potential challenges that can impact efforts, policies, and infrastructure of racial equity work in our jurisdiction? **Establish systems that monitor racial equity policy quakes** at and between local, state, and regional levels.

Establish deeper ties at federal, regional, state, and local agencies to exchange information ahead of public news.

Use the GARE Online Community for local government network support, updates on research and local efforts.

Engaging the Community

How could we meaningfully engage with our communities to strengthen our coordination, collaboration, and collective resilience? **Educate communities and civil society** on state and local laws that continue to empower equity work.

Leverage allies inside and outside of government.

Harness the narrative power at the community level.

PREPAREDNESS

Preparedness involves proactive measures such as training, strategic planning, and educational activities to equip individuals and organizations with the necessary tools and knowledge. These efforts will enable you to effectively respond to direct attacks, opposition, or disruptions that may threaten the continuity of racial equity efforts.

Funding & Resources

How can we protect and/or cultivate funding streams to sustain racial equity work?

Braid funds together to increase resilience from challenges by creating mutual benefit/interest.

Blend funds with external funders to champion the effort and create a matching incentive.

Ensure existing funding efforts are backed with data and community support to fend off challenges.

Readying Your Response Team

How could our jurisdiction create and best prepare a Rapid Response Team? **Ensure Rapid Response team is trained** in effective competencies on jurisdiction threats and solutions.

Integrate racial equity lens into contingency planning processes to address targeted communities.

Engage in researched scenario planning to ensure the most harm reductive strategies are chosen.

Protecting Democratic Discourse

How can we work to ensure healthy and productive discourse across our jurisdiction and combat divisive misinformation and disinformation? **Assemble a Democratic Discourse team** to effectively manage internal and external messaging campaigns.

Ensure the Democratic Discourse team works with experts and emerging research for debunking strategies.

Train jurisdiction staff on tiers of proactive and responsive debunking strategies for digital and interpersonal use.

Public Education Campaigns

How can we best prepare our local communities for unified action in the face of racial equity challenges and disruptions? **Share clear goals** that will teach your community to be unified responders to racial equity disruptions.

Share training for the community to attend and lead for greater organization on probable response needs.

Unite with local businesses, schools and community organizations to coordinate preparedness efforts.

RESPONSE

Response emphasizes the importance of actively addressing disruptions to racial equity initiatives with well thought out planning, decisive action, and a commitment to the underlying principles of fairness and inclusion. By concentrating on both immediate actions and long-term solutions, local, regional, and state governments can not only overcome challenges but also reinforce and solidify the foundation of their racial equity initiatives.

Disruption to Racial Equity Offices

How could a rapid response plan help to stabilize racial equity offices from threatening disruptions?

Disruption to Racial Equity Services

How could a rapid response plan help to stabilize racial equity services from threatening disruptions? **Share intergovernmental backed messages** from a range of local offices to counter attacks.

Use a communication contingency plan for racial equity offices to shelter staff from individual attacks.

Use an operations contingency plan for staff to protect their anonymity while leading racial equity services.

Share intergovernmental backed messages on democratic commitment to providing just and fair aid.

Use communication contingency plan to ensure vulnerable citizens can find and maintain service.

Use an operations contingency plan for distribution of services through other local offices or branches.

Racial Equity Threats to Your Community

How could a rapid response plan help to stabilize racial equity related community needs from threatening disruptions? **Share intergovernmental backed messages** on democratic commitment to civic and human rights.

Enact contingency plans that aid safe haven, sanctuary and lifeline interventions for targeted citizens.

Disperse information to citizens about permitted protest areas and procedures to aid their safety.

Legal Threats to Racial Equity

How could a rapid response plan help to stabilize racial equity affirming laws? **Share intergovernmental backed messages** on democratic commitment to civil and constitutional rights.

Identify organizations that offer interpretation and analysis for threats that pose legal changes.

Identify legal experts willing to work with your general counsel.

RECOVERY

Recovery involves establishing robust, flexible, and sustainable actions within government institutions that restore and revitalize its racial equity efforts. Such systems are essential not only for helping institutions rebuild after setbacks, but also for driving the continued advancement of long-term racial equity initiatives.

Recovery for Your Equity Office

What actions can we take to effectively recuperate our office after harmful racial equity disruptions?

Recovery to Your Racial Equity Services

What actions can we take to effectively recuperate our services after harmful racial equity disruptions?

Deploy a wellness plan that includes employee assistance, counseling services, and integrative feedback.

Conduct impact/needs assessments to help guide a restructuring of equity office/work.

Determine best structure, placement, and framing for sustainable redesign of equity office/work.

Use impact/needs assessments to identify operational and financial realities to guide a remodel.

Determine best locations for service and best channels for communication to meet community needs.

Collaborate with community to identify solutions and service adaptations and determine effective ways to integrate feedback.

Community Recovery Efforts

What actions can we take to effectively recuperate our community after racial equity disruptions? **Conduct impact/needs assessments** to strategize how to most effectively provide aid and support.

Work with state, local, tribal, territorial, and neighborhood partners to distribute aid for the community.

Prioritize recovery efforts from immediate to long-term needs and allocate resources accordingly.

Additional Recovery Efforts

What supplemental actions could we take to effectively mitigate against future racial equity disruptions? **Identify racial equity policies and practices** that should be codified into law for long term protection.

Determine other policy safeguards that can be instated to protect offices, services, and communities.

Use base-building strategies with community and partners to strengthen intersectional supports and care.
